- (6) The School shall not deny admission to any child for lack of age proof if such admission as sought subsequent to the extended provided prescribed for admission on the on the ground of religion, caste or race, place of birth or any of them. 21
- (7) The School shall ensure: -
- (a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school
  - (b) No child shall be subjected to physical punishment or mental harassment.
- (c) No child is required to pass any board examination till the completion of elementary education.
- (d) Every child completion elementary education shall be awarded a certificate as laid. down under Rule 23.
  - (e) Inclusion of students with disabilities/special needs as per provision of the Act.
- (t) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act

- (b) The teachers shall not engage himself or herself for private teaching activities.
- (8) The School shall follow the syllabus on the basis of curriculum bad down by appropriate authority.
- (9) The School shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act
- (10) The School shall maintain in the standards and norms of the school as specified section 19 of the Act. The incilities reported at the time of last inspection are as grants under: -
